The Ponce Inlet Corvette Club originated in March of 2005. The Club has grown into a respected, active and acknowledged Corvette Club that meets in New Smyrna Beach, Florida. In January of 2005, local Ponce Inlet residents Gary and Dianne Swanhart purchased a new C6 red coupe from local Chevrolet Dealer Jon Hall. The twist in the story took place shortly after they got the car home. Jon Hall was contacted by representatives of Wrangler Jeans and Dale Earnhardt Jr. to see if the Dealership could provide them with a red Corvette to film a Wrangler Jeans commercial at the Daytona International Speedway. At the time they did not have another red C6 in stock but they remembered just having delivered a red C6 coupe to Gary and Dianne. The Swanhart's were contacted and asked if they would be willing to support the filming with their new Corvette. They agreed and Gary and Dianne took the new C6 to the track and met Dale Jr. During the filming they both got to meet him and had Dale Jr. sign the dash of their new Corvette. Shortly after that event the Club was organized and Jon Hall Chevrolet became the Club's first Sponsor. The initial meeting was held on February 22, 2005. Sixteen prospective members from Ponce Inlet, Daytona Beach Shores, Ormond Beach and Port Orange were in attendance. A general design for a "Club Logo" that depicted the Ponce Inlet Lighthouse with a C5 emblem across the background of the lighthouse was adopted. Since that initial meeting, the Ponce Inlet Corvette Club has become well known for attending local car shows. cruise-ins and is a Charitable and Social Club. Members are owners of Corvettes from 1958 to 2022. Proceeds from our annual VETTES AT ONE DAYTONA show and fund raisers are donated to charity. Our annual car show has become a focal point of Corvette Clubs and Corvette enthusiasts throughout the state of Florida.

## **BECOMING A PICC MEMBER**

Membership shall be open to any Corvette owner over 21 years of age and their spouse or significant other. Any membership paid on or before March 22, 2005 shall be considered a Charter Membership. Each membership shall have only one vote. Application will be made on the club membership form (available on our website) and given to the Membership Chairperson. The Membership Chairperson forwards to the treasurer, all membership registration funds. Members that no longer own a Corvette will have six months to obtain ownership in another Corvette or forfeit membership in the Club. There will be no refund of dues to members who forfeit their membership. Any member whose annual dues and fees are current is considered an Active Member. If a club member resigns from the Club, that member will not be entitled to participate in any Club functions, until that member formally requests a new membership application. At that point, all new membership requirements must be once again satisfied. Our annual membership dues are \$50.00. Membership dues are payable at time of application to the Club.



The National Corvette Museum in Bowling Green, Kentucky is acknowledging the ten-year anniversary of a cave-in that damaged the museum swallowed up eight Chevy Corvette sports cars. Known as the National Corvette Museum sinkhole, the event occurred on February 12th, 2014, around 5:38 a.m. local time and gained worldwide attention. Now, the museum will launch a new exhibit that documents the cave-in.

"The National Corvette Museum captured the attention of the world a decade ago, and we've spent the last decade turning misfortunes into hard-fought and well-earned triumphs," said museum Board Chair, Kaye Wagner. "With over 15 major exhibitions, tens of millions of dollars in renovations and improvements, the creation of a STEAM-focused education gallery, the addition of a world-class Motorsports Park to our campus, and countless other advances in the last ten years, the National Corvette Museum is proud of our journey."

The cave-in occurred in the museum Skydome structure and created a 40-foot-by-30-foot hole in the floor. Video and still images of the event went viral, bringing international attention to the museum. Repairs cost a whopping \$3.2 million, although the event didn't lower attendance — in fact, attendance increased.

Now, the museum is poised to open a new exhibit that documents the event. Called "Ground to Sky", the exhibit will include "the moments, memories, and machines that made history that fateful day, while focusing on the accomplishments of countless Museum staff and supporters who built back and reimagined a National Corvette Museum that continues to evolve," the museum states.

The new "Ground to Sky" exhibit will open Friday, June 14th, 2024, and will run through September 15th, 2024. The exhibit will feature two fully restored vehicles recovered from the sinkhole, including a 2009 "Blue Devil" ZR1 and the 1 Millionth Corvette produced (1992 model year, white exterior).

The National Corvette Museum is located just down the street from the GM Bowling Green Plant in Kentucky, the exclusive producer of the Chevy Corvette since 1981.







### Man Allegedly Steals Semi Truck Carrying 10 Corvettes

When most people need a ride they phone a friend. When that's not an option they might call a rideshare service and some go as far as to hitchhike. Few decide that stealing a vehicle is their only option. Despite that, it's allegedly what one man in Arizona did a few days ago. What's truly bizarre though is that for whatever reason, the vehicle he chose just so happened to be a big rig with over \$1.25 million bucks worth of Chevrolet Corvettes on the trailer.

The theft went down on February 15th according to the Cochise County Sheriff's Office. It says that the subject, a 23-year-old struck up a conversation with a truck driver at the Wilcox Loves Truck Stop. Then, as the truck driver was boarding his vehicle, the suspect assaulted the driver, threw him from the truck, and hopped in the driver's seat. After locking the vehicle, the suspect drove away with 10 Corvettes in tow.

Authorities say that they caught up with the suspect and the semi-truck about nine miles down Fort Grant Rd. An officer evidently attempted to stop the vehicle but to no avail. Only after driving recklessly and forcing cars off of the road did the driver ultimately pull over and surrender to officers.

How exactly did they think the chase would end? Of all the possible vehicles on the road, a semi-truck might be the worst choice for someone trying to outrun the law. Yes, somehow it's worse than a PT Cruiser. At the same time, it's not like the police could've used a PIT maneuver on the big rig. Maybe the suspect planned to find a spot where he could off-load one of the Corvettes and then get away. Maybe he just loves Volvo semi trucks. We'll likely never know.

What's clear though is that authorities say he admitted to taking the truck because "he needed a truck to get home as he had just been released from prison." For the time being he doesn't have to worry about that issue since he's facing charges of robbery, felony theft, and 11 counts of Theft by Means of Transportation. The suspect allegedly also said that he didn't steal the truck for the Corvettes themselves.

Chief Hadfield of the Cochise County Sheriff's Office stated in a post on Facebook.

"I am extremely proud of the officer and deputy involved in this investigation. The deputy and officer showed great restraint and patience in bringing a serious crime to a peaceful resolution, all while keeping the property of others from being damaged. The stolen vehicle was safely recovered without damage and was released to the driver so he could continue his delivery. Again, I thank the officer and deputy who were involved in this investigation for keeping our citizens safe."

Managing to apprehend the suspect without injury to any of the parties involved and without damage to the property involved is a noteworthy accomplishment. Certainly, the families of all involved can be happy about that as can the future owners of those Corvettes. Now, let's just hope that they drive them in such a way that this isn't the most exciting thing they are ever involved in.


The official 24 Hours of Le Mans entry list has come out today and I am already feeling a bit nostalgic for the good old days of Corvette Racing. Yes, the good news is that there are Corvettes headed to Le Mans, but having all the fun this year will be a team that is not named "Corvette Racing."

There was a whole bunch of tradition going all the way back to Corvette Racing's early days of Le Mans, where a scrappy team from America showed up at scrutineering wearing cowboy hats before switching to berets. They were also known for spray painting a skull on the pit floor, and summoning the crew to lunch using a train horn.

Other than 2020 due to Covid, Corvette Racing has been a fixture at the 24 Hours of Le Mans since 2000. The team has 9 wins in 24 races, and also 13 other 2nd and 3rd place podium finishes over the years. Last year, Corvette Racing got their first Le Mans win in the C8 era with the No. 33 team coming out on top in the class.

On the positive side, you will see two Corvettes listed in the Le Mans' LMGT3 class. This year, the hopes and dreams of another Le Mans championship for Corvette now falls on the shoulders of British team TF Sport, who is campaigning the two Corvette Z06 GT3.Rs in the World Endurance Championship. Chevrolet did their due-diligence and TF Sport has done well at Le Mans with first place finishes in class in 2020 and 2022, while in 2021 they came in 2nd. Ben Keating had spent time with TF Sport prior to coming over the WEC Corvette team last year, so his input was also likely considered.

Does the FIA still invite the championship winning GT teams from IMSA to participate? Would GM/Chevy Racing even allow Corvette Racing to compete directly with customer teams? Doesn't seem likely. Still, we are fortunate to still have Corvettes racing the greatest stage. TF Sport will have the full support of the Corvette Nation, so let's hope they are up to the task!







## GT3.R FAQ

The track-only Corvette Z06 GT3.R race car is modified with racing-specific equipment and will comply with FIA GT3 regulations. Design and development of the mid-engine Z06 GT3.R is a collaboration between GM's Motorsports Competition Engineering division and Pratt Miller Engineering. The Z06 GT3.R will be eligible for GT3 championships globally and will debut in 2024.

# Can you buy a Corvette Z06 GT3.R at a Chevrolet Dealership?

The Corvette Z06 GT3.R will not be sold through dealerships. Cars will be sold to racing teams who are uniquely equipped to showcase the car on track in competition use.

## How does the Z06 GT3.R compare to the Z06 road car?

The Z06 GT3.R is not a street legal vehicle. The Z06 GT3.R race car is based upon the street legal Chevrolet Corvette Z06. They have the same aluminum chassis, a production engine modified for use in the racecar, and similar aerodynamic features including silhouette and dimensions. The Z06 GT3.R is a fully homologated FIA compliant GT3 racecar with the required roll cage and safety systems.

#### Where is the Z06 GT3.R built?

The Z06 GT3.R is built utilizing the aluminum chassis directly from the production Corvette assembly line in Bowling Green, KY. GM has partnered with Pratt Miller Engineering to construct the Z06 GT3.R in New Hudson, MI

### What engine is in the Z06 GT3.R?

The Corvette Z06 GT3.R features a 5.5L, flat plane crankshaft DOHC V-8 engine derived from the production Z06. This engine began on-track development in 2019 with the initial testing of the C8.R race car, in conjunction with its use in production on the Z06 road car.

The Chevy Corvette received a clean-sheet redesign for the 1963 model year, marking the start of the second generation known as the Mid Years or C2. It now carried the Sting Ray moniker, taking some of its styling cues from the sea creature. The rear suspension evolved from a solid axle to an independent setup, suspended by a transverse leaf spring, vastly improving ride and handling. The Corvette could be had in either coupe or convertible guises for the first time. Available options included power steering, power brakes, power windows, air conditioning, AM/FM radio, leather seats, and a number of performance parts intended for competition use. Interior space was much improved, as was the cargo area on both convertibles and coupes.

Throughout the 1963 to 1967 Chevy Corvette production run, a number of changes improved performance, but none so much as the switch to standard disc brakes in 1965. From personal experience, I can assure you the difference from four-wheel drum to four-wheel disc braking is night and day. Also available for the first time in 1965 was Big Block power. The Mark IV 396 Big Block offered 425 horsepower. The Big Block engine was the death knell for the fuel-injected Corvette Small Block, and 1965 was the last year Rochester mechanical fuel injection was available.

The Mid Year Chevy Corvette would continue to evolve, with the final year being the cleanest design of the run. Some exterior trim was eliminated, giving the Sting Ray a cleaner, less cluttered look. The fender gills morphed from three large vertical slots to five smaller, forward-canted slots. The back-up light had been part of the taillights in previous years, but became a separate unit mounted above the license plate. Silver-painted five-slot rally wheels with trim rings and center caps replaced painted steel wheels with hubcaps. Inside the Corvette, the passenger grab handle above the glove box was eliminated, and the parking brake was moved from right of the steering wheel beneath the dash to the center console where the padded armrest used

Engine options for the 1967 Chevy Corvette included 300- or 350-horsepower 327 cubic-inch Small Blocks, or 427 cubic-inch Big Blocks rated at 390, 400, or 435 horses. A fourth 427 was available in the special-order L88 that was grossly underrated at 430 horsepower.

The L88 could easily achieve 550 to 650 horsepower with a set of exhaust headers and some tuning. Big Block Corvettes were visually differentiated by their hoods that had a power bulge and "stinger" painted in contrasting colors.

Our feature 1967 Chevy Corvette Big Block Coupe is one of three Central Office Production Order Sting Rays built. A COPO car is one that is ordered with options not typically available. Most COPO cars were specialty vehicles like police cruisers, taxis, ambulances, or the like. Some, like COPO Camaros, were performance specials with engines and other goodies that weren't on the standard option list. But a COPO car could also be one that was ordered with non-standard color combinations, like the three 1967 Big Block Corvettes that were specced with unusual colors. This 1967 Sting Ray coupe is finished in Silver Pearl with a light blue Big Block stinger over Bright Blue interior. Silver Pearl was typically only available with Black or Teal Blue interiors. According to the National Corvette Restorers Society Shipping Data Report, the Corvette was built May 26th, 1967, and shipped to Haney Chevrolet in Orlando, Florida.
